PRESIDENT'S REPORT – prepared by Kath Kendall/D Hale

Personally, it has been a challenging year, being stranded in Australia for much of the year and I would like to take this opportunity to thank the Board for knuckling down and keeping the club going resulting in a successful year. Thanks too, must go to Club Captain – Dennis Hale – who wrote this report for me. Without further ado – I shall read Dennis' report.

The Tokoroa Bowling Club has had another challenging season due to the COVID situation continuing to disrupt our programme for the 2021/22 season.

We were able to complete our Club Champs by moving the various games around to suit. We also managed to get the majority of our Thursday night Business House programme and Wednesday club days in barring the odd missed bad weather day.

We also had some challenges internally with our President stranded in Australia for most of the season and our Vice President Sam Kennedy standing down due to ill health. Fortunately we were able to draft former president Neville Risbridge in as Interim President.

On a positive note, the Board applied for and was granted a large amount of funding for various projects in and around the club from Grassroots Charitable Trust. With these grants we were able to purchase a new ride on mower, new spray unit and 16 new sets of bowls which proved very popular with the Business House teams.

The latest funding round has meant that we are able to make a start on completely renovating the No 2 green which has been a mammoth undertaking, removing 20 mm of the old turf and laser levelling the green – done by a professional firm who specialises in this type of work. A small but enthusiastic group of members have removed all the stones and dirt out of the ditches, replacing them with sand and we are looking to replacing the ditch and wall carpets shortly. All the benches were completely stripped back and repainted – looking good.

On the playing side of things, congratulations must go to Maia Wilson who was selected for the Waikato Open Women's team. Gordon Bond and Paul Howe won the Champ Champs in the Men's Pairs and at the time of writing, Gordon Bond is in the finals to defend his Champ Champs Men's Singles title. In our own Club Championships, we had some very closely fought games and congratulations to all our winners. Unfortunately, the 2021/22 season three long term members passed away – Life Member Sam Kennedy, Ladies Life Member June Wilson and long time member Jim Flutey.

The Board and Match Convenors have worked very hard this season and have done a fantastic job. Thank you to them all.

SUBSCRIPTIONS
