## **MATTERS ARISING**

## FINANCE

## **GENERAL BUSINESS**

**Greenkeeping** – Waikato Greenkeepers Association will be holding their meeting here on Monday 5 August around 11am. Has asked if we can put on a cup of tea and maybe some morning tea.

Seed has been received for No 1 Green – maintenance on the ditches has been undertaken over the past month.

Building Maintenance – a painter has been sourced who will paint both toilets – labour only – for \$300. Approval given for this. AM has costed a 10 litre of wall and ceiling paint at \$58 from Bunnings – next closest price was Warehouse @\$99. Approval given to purchase paint. Call has gone out for anyone who would have spare rollers and tray for the painter to use.

**Toilets** – Quotes have been received from Mico Wakefield - \$2000 for 3 toilets. However, the cost to install caused a few heart palpitations - \$400 **per** toilet! This was thought to be excessive and have instructed RM to get another quote from The Good Plumber. We also need to get another quote for the repair/replacement of the broken Gas Heater.

- **DH** advises that he was approached by Tok Club Manager and asked in his capacity as a Bowling Club Board Member - to sign approval for an application from L Broadhurst to fund entry fees for the Matamata Chartered Club's Three-Day Tournament.
- Match Committee organising a Coaching training session for members in the first couple of weekends in September and also include Eileen Stephens (Bowls Waikato Umpires Association) to come down and do a quick overview of essential laws players need to know

**Welfare Report** - Danny Carr has finished his treatment and is going along well. Robin Reti is scheduled to receive her new hip before October. Ex-President – Bill Nuttall is not doing well – he is being transferred back to Tokoroa Hospital shortly.
