GENERAL BUSINESS

Boxing Day Tournament: as no-one is going to be available to run it, it has been decided to cancel it. **Moved the Boxing Day tournament be cancelled – M Albutt / G Norris-Palmer (Carried)**

Farewell for Neville: CC advised that Neville does not want a fuss. MA suggested maybe an afternoon tea – she will approach him to get his preferences.

- **Repairs & Maintenance:** referring to the letter from Tok Club MA read the letter out and advised that the Tokoroa Club is adamant that as they own the clubrooms, they will be picking up all the costs involved. The rotten pile under the Eastern veranda is a major contributing factor to the sinking of the eastern corner of the clubrooms.
- **Subscription Arrears:** LM reported that as at the meeting date, 23 members had not renewed their membership (8 of which are social members) which represents almost 30% of our membership base total outstanding subs \$1720.00 LM to send out a gentle reminder to those members via text.
- **Match Committee Report:** Congratulations to Gordon Bond and Paul Howe for victories in the Waikato Championship Pairs and together with Terry Moffat and Harold Veza, the Waikato Champ Fours.

The two tournaments we have run — Bill Garrick and Morrissey's went smoothly although with the Morrissey's we only put a time limit on the games and not an end limit — which meant that the Hinuera team managed to play 17 ends in their first two games. In a tournament with byes, this gives an advantage to the bye teams when calculating averages.

Decided that from now on the Open Opt Triples games will be 1 ½ hrs or 15 ends
